

The Harborage

Hometown Healer? Dr. George F. LaPaul By Scott D. McGinnis

Dr. LaPaul was not remembered as fondly as the village physicians Dr. Edward R. Perkins or Dr. Hugh C. Arey covered in our earlier Hometown Healer articles; however, his imprint on the Village of Excelsior is undeniable.

George Frederick LaPaul was born February 14, 1861 in Moncton, New Brunswick, Canada. His family moved to Waseca, Minnesota in March 1865. He entered the Lake Minnetonka scene in 1883 as Captain of the steamboat Reindeer and subsequently Captain of the JYC (Judgment Yet to Come), also known as the Hebe, 1884-1885. His occupation took a turn in 1885 when he was accused of recklessness and was



Dr. LaPaul's practice was in the gateway district of Minneapolis and he emerged in the forefront of the electro-therapeutic movement

stripped of his license to operate a steamboat. His license was reinstated when the state inspector finally determined that the false allegations were instigated by malice. Nevertheless, he changed his profession because he had graduated from the University of Minnesota Medical School that year. The next year, he married an Excelsior woman, Carrie May Hopkins, the daughter and sister of fellow Lake Minnetonka steamboat captains, Alfred Hopkins and George Hopkins.

In November 1890, Dr. LaPaul began advertising treatment for tuberculosis of the joint with what was referred to as "the largest electrical apparatus in the country." This earned him the consternation of the Minnesota Medical Society. The Society's board of censors proffered charges of unprofessional conduct in

A TRIBUTE TO JERRY HOLL

The Society was saddened by the news of Emeritus Member Jerry Holl's death in June. Jerry was a longtime member of the Society's board and an irrepressible volunteer. She was instrumental in the preservation of one of the Society's most renowned - and largest - artifacts, the

sailboat *Onawa*, raising funds and orchestrating its restoration. A gifted artist, Jerry lent her skills to

many other Society projects, including editing, designing and illustrating Ellen Wilson Meyers' "Happenings Around..." books. And she could always be counted on to rope her many friends and family members into sharing her shift hosting at our museum, joining the Society as members or attending Society programs - hooking them on local history in the process.

While she is greatly missed by her fellow volunteers, her industriousness and talent lives on in the many projects she undertook for the Society, and we see her handiwork almost everywhere we look. We are richer for her time with us and would not be where we are today without her.

advertising as a specialist in certain diseases and prevented him from reading his paper, "Hypnotism as a Medical Agent," at their annual convention. By a vote of 63 to 1, Dr. LaPaul was expelled from the Minnesota Medical Society on June 18, 1891.

Speaking on his own behalf, Dr. LaPaul stated that he had done nothing wrong, and that his advertisement did not state he would cure people, only that he would treat their condition. He further stated,

"I use electricity in my treatment, and Dr. ---and Dr. --- and Dr. ---, [mentioning three prominent physicians] have begun the use of it in the same way that I use it, only they don't make their machines succeed as well as I do mine. I tell you what the trouble is, these doctors don't like it because, I use electricity and hypnotism and use them successfully. Now as to advertising, the thing that stirs them up is this [advertisement for my electric system of treatment.] That's what they say they kick on, but the main trouble is that I am getting the business. Talk about ethics! What do they care about ethics when you get right down to it. The fact of the matter is, it's every man for himself in this business as in all others and I'm going to do business to suit myself."


In 1896, Dr. and Mrs. LaPaul left their Minneapolis residence and moved to Excelsior for the grand opening of their new establishment, the LaPaul Hotel.



The LaPaul Hotel was purchased by Richard Golden in 1918 and renamed the Excelsior Bay Hotel. Photograph circa 1920.


The hotel was located on the hill behind the current Dock Cinema off of Water Street between Lake and Second Streets. In 1912, he converted part of the hotel into a sanitorium and installed his electrical apparatus for the treatment of patients.

Along with the purchase of the hotel property in 1894, the LaPauls also acquired the shoreline in front of the site. This included the Red Line Pavilion that stood just west of the foot of Water Street on Excelsior Bay. The pavilion played a central role in LaPaul's plans to reenter the steamboat business.

The steamboat *George* was built for Dr. George F. LaPaul by George E. Day and George Godfrey and launched on Excelsior Bay May 25, 1901. The *George* was a 125-foot long double-deck sternwheeler with a capacity of 800 passengers. It was then the largest vessel on Lake Minnetonka and made the Red Line Pavilion its home port.

After a property dispute between LaPaul and the Village of Excelsior, the pavilion property became a point of contention. The Village raised their property tax on the lot and in February 1902, proposed construction of a new dock just ten feet from the

LaPaul's dock which would render one side of it useless to the 24-foot-wide steamer *George*. The LaPauls finally filed suit against the Village. In settlement discussions, the Village agreed to not build any dock within 70 feet of the west side of the LaPaul's dock.

Part of this vendetta might have been Dr. LaPaul's failed bid to be Village Council President in 1897. He was part of a last-minute slate of candidates that were pro liquor license in the Village election. The prohibition candidates won the election, but lost the liquor fight as Excelsior approved the sale of liquor for the first time. Dr. LaPaul took advantage of the new ordinance and leased the basement of the LaPaul Hotel to Simon Kolodziej, who immediately applied for and received one of Excelsior's first liquor licenses.

Dr. LaPaul died November 12, 1927 at his home in Excelsior and was survived by his wife, brother, and two sisters. Reverend Charles Fox Davis, former minister of the Excelsior Methodist Church and friend of the deceased, gave the eulogy as reported in the *Minnetonka Record*, November 18, 1927.

"Characteristically different, broad-minded and generous, he said Dr. LaPaul's friendship was most helpful to those fortunate to possess it. In closing Mr. Davis said that while humanity is never perfect, neither was Dr. LaPaul perfect, but he said, "Let us remember the many good acts of our brother, forgetting all the mistakes that flesh is heir to."






